

ANNUAL TOWN MEETING

Clerk Schulte called the Annual Town Meeting for Edwardsville Township to order.

The Annual Town Meeting for the year 2015 was held at the Lincoln Middle School, 145 West Street, Edwardsville, Illinois in the said Edwardsville Township, this April 14, 2015, 7:20 p.m. in compliance with the Annual Town Meeting and Provisions of law, as published in the Edwardsville Intelligencer on March 13, 2015.

Electors: 22 Attendees: 6

First order of business was the election of a Moderator for the meeting. Motion by Doug Hulme and seconded by Bob Hulme to nominate Mark Rabe. Motion by Supervisor Miles and seconded by Trustee Head to nominate Mike Campbell. There being no other nominations, Motion to close Nominations made by Trustee Head and seconded by Supervisor Miles. Motion Passed. Clerk Schulte asked everyone who supports Mark Rabe to stand in the right aisle and everyone who supports Mike Campbell to stand in the left aisle. Mark Rabe 11 Electors, Mike Campbell 11 Electors. Clerk Schulte called a recess at 7:32 P.M. Clerk Schulte called the meeting back to order at 7:45 P.M. Motion by Mark Rabe and seconded by Trustee Williamson to draw a name out of a hat. Motion Passed. Clerk Schulte appointed Kevin Rust, 11 Squire Drive, Glen Carbon to draw a name out of a hat. Mark Rabe was elected Moderator.

Clerk Schulte then gave Mark Rabe the Oath of Moderator.

Moderator Rabe asked Clerk Schulte to read the minutes of the last Town Meeting held on April 8, 2014.

Moderator Rabe asked for a motion to approve the Minutes as read. Motion by Ron Williams and seconded by Bob Hulme. Motion Passed.

Moderator Rabe asked Clerk Schulte to distribute the Financial Affairs of the Township of Edwardsville and the Edwardsville Township Road District as submitted to him by Supervisor Miles, Supervisor and Treasurer of the Road District. Clerk Schulte distributed the Annual Financial Statement.

Moderator Rabe asked if there were any questions on the statement of Financial Affairs of the Town of Edwardsville. Moderator Rabe asked if there was any discussion. There being none, a motion was made by Trustee Head and seconded by Williamson to approve the Statement of Financial Affairs: Motion Passed. Voting "Yes" 22 Voting "No" 0.

Motion to hold next Annual Town Meeting on April 12, 2016 at 7:00 P.M. made by Jeanne Wojcieszak and seconded by Supervisor Miles. Voting "Yes" 30 Voting "No" 0

Point of Order by Doug Hulme, Doug expressed concern as to why petitions submitted were not put on the agenda.

Ron Williams stated that the Township Government was not very popular in the State of Illinois and that Governor Rauner has appointed a task force to investigate the relevancy.

The moderator asked if there was any further business to come before this Annual Town Meeting. There being no further business a motion to adjourn would be in order. Motion by Trustee Head and seconded by Trustee Supervisor Miles to adjourn at 8:06 p.m.


