**Setting Salaries of Township Officials Elected**

**April 7, 2009**

**WHEREAS**, according to 60 ILCS 1/65-20, the compensation of township officers shall be set by the township board at least 180 days before the beginning of the terms of office.

**WHEREAS**, according to ILCS 1/65-20, the compensation for the road district treasurer shall be fixed by the township board and shall be not less than \$100 or more than \$1,000 per year.

**WHEREAS**, according to 605 ILCS 5/6-207, the compensation of the highway commissioner shall be fixed by the township board at an annual salary of not less than \$3,000 to be paid in equal monthly installments, or a per diem amount for each day he or she is necessarily employed in the discharge of official duties;

**WHEREAS**, according to 35 ILCS 200/2-70, the compensation of the township assessor shall be set by the township board at the same time the board sets the compensation of its township supervisor.

**NOW THEREFORE, BE IT ORDAINED BY** Board of Trustees of Edwardsville Township that the compensation of the township officials for the four year term beginning May 18, 2009 and ending May 19, 2013 (January 1, 2010-January 1, 2014 for assessor) shall be as follows:

**SECTION 1:** The salaries for township officials shall be as follows:

Supervisor's Salary: Effective for each of the following years:

May 18, 2009 thru May 16, 2010 \$50,141.52 ; May 17, 2010 thru May 15, 2011 \$51,395.04 ;  
May 16, 2011 thru May 20, 2012 \$52,680.00 ; May 21, 2013 \$53,996.88

2010-Supr.-\$46,550.62; Town Board Chairman.-\$3,844.42; Road District.-\$1,000.00=\$51,395.04  
2011-Supr.-\$47,739.47; Town Board Chairman.-\$3,940.53; Road District.-\$1,000.00=\$52,680.00  
2012-Supr.-\$48,957.83; Town Board Chairman.-\$4,039.05; Road District.-\$1,000.00=\$53,996.88

Assessor Salary: Term is from January 1, 2010 thru January 1, 2014

May 16, 2011 thru May 20, 2012 \$53,704.12; May 21, 2013 \$55,315.25



