AUTHORIZING AN ADVISORY QUESTION OF PUBLIC POLICY

WHEREAS, 60 ILCS 1/30-5 requires all Townships in the State of Illinois to hold an annual township meeting on the second Tuesday of April; and

WHEREAS, this Township held its annual town meeting at 7:00 p.m. on April 8, 2014 at the Hays Mallory Community Building, 216 Crane Street, Edwardsville, in accordance with 60 ILCS 1/30-15; and

WHEREAS, 60 ILCS 1/30-205 allows the majority of electors present at a town meeting to authorize that an advisory question of public policy be placed on the ballot at the next regularly scheduled election in the Township.

NOW, THEREFORE, BE IT RESOLVED by the electors of Edwardsville Township, Madison County, Illinois as follows:

SECTION 1: That the Edwardsville Township Electors, properly convened and assembled at the annual township meeting of Edwardsville Township, do hereby authorize the following advisory question of public policy to be placed on the general election ballot for submission to the voters in the township of Edwardsville, in Madison County, in the State of Illinois, for the November 4, 2014 election:

Shall the U.S. Constitution be amended to clearly state that the rights of persons protected by the U.S. Constitution are the rights of natural persons and are not those of corporations or other artificial entities and that money is not speech within the meaning of the First Amendment?

SECTION 2: That the electors further order the Township Board to certify the question to the proper election officials, who shall submit the question in accordance with the general election law.

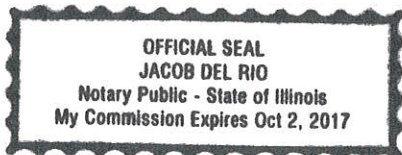

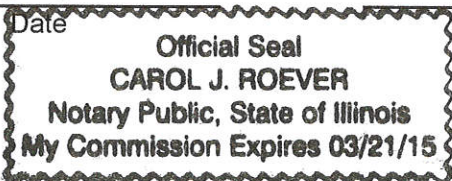
