EDWARDSVILLE TOWNSHIP RECEIVES DONATION FOR PARK

Edwardsville, Illinois – August 25, 2014. Edwardsville Township Supervisor Frank Miles received a \$2,000 donation from Todd Sivia of Sivia Business and Legal Services at the Business After Hours event the Township and Sivia hosted in Edwardsville Township Community Park on Thursday, August 21, 2014.

“It was a pleasant surprise,” said Frank Miles, Township Supervisor. “We appreciate the generosity of Sivia Business and Legal Services and we will use the money for more improvements at Township Park.”

The Township has completed several improvement projects this summer with the help of a Youth Work Corp grant from the Illinois Department of Natural Resources. “The youths employed with the grant funds have painted the entire perimeter fence, the tennis court fences and all of the pavilions,” said Miles in his remarks during the Business After Hours.

More than 75 members from the Edwardsville/Glen Carbon Chamber of Commerce and their families enjoyed the Business After Hours and had a chance to win attendance prizes that were donated from other Chamber members. “We were fortunate to have many business donate great prizes,” said Miles. Prizes were donated by The Bank of Edwardsville, Richard’s Brick, Girl Scouts of Southern Illinois, Scheffel & Boyle, Maclair Asphalt, Juneau & Associates, and the Auto Body Shop.

This is the first time the Township has hosted a Business After Hours event. “Being new Chamber members, we wanted to host an event at Township park and have the opportunity to share information about our services with other Chamber members and residents,” said Miles.

The Township has scheduled next year’s Business After Hours for August 20, 2015.
