Edwardsville Township Meeting Minutes

October 24, 2013

The meeting of Edwardsville Township was called to order by Supervisor Miles at 7:00 p.m. Present were Supervisor Miles, Trustees Krumeich, Picarella, Kennett, Head, Highway Commissioner Henschen and Clerk Schulte. Assessor Klopmeier was excused.

Highway Commissioner Henschen led the Pledge of Allegiance.

Supervisor Miles introduced Jeanne Wojcieszak, the Township's new Administrative Assistant.

Supervisor Miles introduced the new Township Attorney Tonya Genovese and her partner Beth Gori.

Motion to approve the minutes of the September 24, 2013 meeting made by Trustee Kennett and seconded by Trustee Head. Motion Passed. Voting "Yes" were Trustees Krumeich, Picarella, Kennett, Head and Supervisor Miles.

Motion to approve the expenditures of Township and Highway Funds for the month September 21, 2013 thru October 18, 2013 made by Trustee Head and seconded by Trustee Picarella. Motion Passed. Voting "Yes" were Trustees Krumeich, Picarella, Kennett, Head and Supervisor Miles.

Supervisor Miles received a Public Hearing Notice from the Madison County Boards of Appeals to be held on October 24, 2013 at 9:15 A.M. – File #Z13-0051.

Supervisor Miles reported the quarterly meeting of the Madison County Township Officials will be Thursday, October 24, 2013 at the Pin Oak Township Building.

Supervisor Miles distributed the September 2013 Circuit Clerk Fines Report. Which will now be available each month in the packet.

Elizabeth Heil and Steve Langendorf of Scheffel & Co. presented the Edwardsville Township Audit Report and Financial Statement for the year ending March 31, 2013. The Auditor gave Edwardsville Township a "clean opinion". Motion to approve Auditor's report made by Trustee Krumeich and seconded by Trustee Head. Motion Passed. Voting "Yes" were Trustees Krumeich, Picarella, Kennett, Head and Supervisor Miles.

Motion to approve a bid to repair the Township Parking Lot, from Seal King Construction in the amount of \$2340.00 made by Trustee Krumeich and seconded by Trustee Picarella. Motion Passed. Voting "Yes" were Trustees Krumeich, Picarella, Head and Supervisor Miles. Voting "No" was Trustee Kennett.

Motion to table the Cleaning Contract Bid until next month to clarify the contract, made by Trustee Krumeich and seconded by Trustee Picarella. Motion Passed. Voting "Yes" were Trustees Krumeich, Picarella, Kennett, Head and Supervisor Miles.

Supervisor Miles will appoint a Personal Policy Review Committee. Supervisor Miles appointed Trustees Kennett and Picarella to serve on this committee and review Policies.

Motion to approve Resolution No. 2013-R09, a resolution authorizing signatures on bank accounts for the Township of Edwardsville. The official signatories will be Frank O. Miles, Supervisor Jeanne M. Wojcieszak, Administrative Assistant, Christine Doty, Bookkeeper. Motion made by Trustee Picarella and seconded by Trustee Head. Motion Passed. Voting "Yes" were Trustees Krumeich, Picarella, Kennett, Head and Supervisor Miles.

Motion to approve Resolution No. 2013-R10, A resolution authorizing new signature cards for Safe Deposit Box and to designate the person or persons to have access thereto. Wendy Leonard, Administrative Assistant, to be removed due to retirement. The following names and signatures be added, Jeanne Wojcieszak, Administrative Assistant and Christine Doty, Bookkeeper. Motion Passed. Voting "Yes" were Trustees Krumeich, Picarella, Kennett, Head and Supervisor Miles.

Supervisor Miles appointed Trustee Krumeich as the Township's Liaison to the Madison County Township Officials.

Supervisor Miles lead a discussion on the Hays Mallory Community Building. Supervisor Miles will appoint a committee next month to conduct a survey on the cost and income on the building. Also to do a marketing study to check other available resources. Report to come in January.

Supervisor Miles will appoint a Financial Services Review Committee in November. The committee will be made up of citizens in the finance and IT field. Report/recommendations due in January.


Supervisor Miles reported on October 24, 2013 the SWOT Team will assist at the Park.

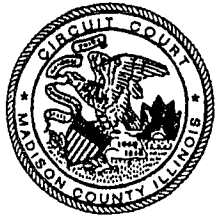
