**Setting Compensation of Township Officials For The Four Year  
Term Beginning May 20, 2013 through  
May 15, 2017 Edwardsville Township, Madison County, Illinois**

**WHEREAS**, according to 60 ILCS 1/65-20, the compensation of township officers shall be set by the township board at least 180 days before the beginning of the terms of office.

**WHEREAS**, according to ILCS 1/65-20, the compensation for the road district treasurer shall be fixed by the township board and shall be not less than \$100 or more than \$1,000 per year.

**WHEREAS**, according to 605 ILCS 5/6-207, the compensation of the highway commissioner shall be fixed by the township board at an annual salary of not less than \$3,000 to be paid in equal monthly installments, or a per diem amount for each day he or she is necessarily employed in the discharge of official duties;

**WHEREAS**, according to 35 ILCS 200/2-70, the compensation for the township assessor shall be set by the township board at the same time the board sets the compensation of its township supervisor.

**NOW THEREFORE, BE IT ORDAINED BY** Board of Trustees of Edwardsville Township that the compensation of the township officials for the four year term beginning May 20, 2013 and ending May 15, 2017 (January 1, 2014-January 1, 2018 for assessor) shall be as follows:

**SECTION 1:** The salaries for township officials shall be as follows:

Supervisor's Salary: Effective for each of the following years:

May 20, 2013 thru May 19, 2014 \$26,000.00; May 20, 2014 thru May 18, 2015 \$26,000.00;  
May 19, 2015 thru May 16, 2016 \$26,000.00; May 17, 2016 – May 15, 2017 \$26,000.00.

2014-Supr.-\$25,000.00/Town Board Chairman-Road District.-\$1,000.00=\$26,000.00  
2015-Supr.-\$25,000.00/Town Board Chairman-Road District.-\$1,000.00=\$26,000.00  
2016-Supr.-\$25,000.00/Town Board Chairman-Road District.-\$1,000.00=\$26,000.00  
2017-Supr.-\$25,000.00/Town Board Chairman-Road District.-\$1,000.00=\$26,000.00

Township Clerk Salary: Effective for each of the following years:

May 20, 2013 thru May 19, 2014, \$6,200.00; May 19, 2014 thru May 18, 2015 \$6,200.00;  
May 18, 2015 thru May 16, 2016 \$6,200.00; May 16, 2016 thru May 15, 2017 \$6,200.00.

Trustees Salary: Effective for each of the following years:

May 20, 2013 thru May 19, 2014 \$2,500.00; May 19, 2014 thru May 18, 2015 \$2,500.00;  
May 18, 2015 thru May 16, 2016 \$2,500.00; May 16, 2016 thru May 15, 2017 \$2,500.00.

Assessor Salary: Term is from January 1, 2014 thru January 1, 2018

2014 \$57,495.12; 2015 \$57,495.12; 2016 \$58,932.49; 2017 \$60,405.80.

Highway Commissioner Salary: Effective for each of the following years:

May 20, 2013 thru May 19, 2014 \$55,315.25; May 19, 2014 thru May 18, 2015 \$55,315.25;  
May 18, 2015 thru May 16, 2016 \$56,698.13; May 16, 2016 thru May 15, 2017 \$58,115.58.


The salary of the Tax Collector shall be \$0.00 per year due to the fact that the collector no longer is funded position and does not collect taxes as mandated by law.
