

RESOLUTION NO. 2015-R07

A RESOLUTION AUTHORIZING A TRANSFER OF APPROPRIATIONS  
FOR THE GENERAL TOWN FUND

**WHEREAS**, there was adopted on the 22<sup>nd</sup> day of April, 2014, by the Board of Trustees of Edwardsville Township, Madison County, Illinois a Budget & Appropriation Ordinance for the fiscal year beginning April 1, 2014 and ending March 31, 2015; and

**WHEREAS**, it now appears that certain adjustments between appropriated line items in the General Town Fund in said ordinance are desirable and necessary; and

**WHEREAS**, Section 3 of the Illinois Municipal Budget Law (50 ILCS 330/3), as approved July 12, 1937, as amended, authorizes transfer between the various line items within any fund in such Appropriation Ordinance not exceeding 10% of the total amount appropriated in such fund by such ordinance.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Board of Edwardsville, Madison County, Illinois as follows:

**SECTION 1:** That there is hereby transferred from the unexpended balance of the line item **Assessor Contingencies** in the **General Town Fund Three Hundred Forty-Six Dollars and Sixty-Five Cents (\$346.65)** which transferred sum is hereby added to the line item **Assessor Equipment Purchase/Lease** in the same fund, making the adjusted appropriation for the first line item aforesaid **One Thousand Six Hundred Fifty-Three Dollars and Thirty Five Cents (\$1653.35)**, and the second line item aforesaid **Five Thousand Five Hundred Forty-Six Dollars and Sixty-Five (\$5,546.65)**.

**SECTION 2:** That there is hereby transferred from the unexpended balance of the line item **Assessor Contingencies** in the **General Town Fund Fifty-Five Dollars and One Cent (\$55.01)** which transferred sum is hereby added to the line item **Assessor Equipment Maintenance/Service** in the same fund, making the adjusted appropriation for the first line item aforesaid **One Thousand Five Hundred Ninety-Eight Dollars and Thirty-Four Cents (\$1598.34)**, and the second line item aforesaid **Five Hundred Fifty-Five Dollars and One Cent (\$555.01)**.

**SECTION 3:** That there is hereby transferred from the unexpended balance of the line item **Assessor Contingencies** in the **General Town Fund Six Hundred Fifty Dollars and Thirty-Two Cents (\$650.32)** which transferred sum is hereby added to the line item **Assessor Health Insurance** in the same fund, making the adjusted appropriation for the first line item aforesaid **Nine Hundred Forty-Eight Dollars and Two Cents (\$948.02)**, and the second line item aforesaid **Thirteen Thousand Three Hundred Ninety Dollars and Thirty-Two Cents (\$13,390.32)**.

Motion was made by TRUSTEE Fuhler, seconded by TRUSTEE Williamson  
that the Resolution be adopted and approved by 5 Ayes and 0 Nays.
