

Edwardsville Township Meeting Minutes

April 26, 2011

The meeting of Edwardsville Township was called to order by Supervisor Campbell at 7:00 p.m. Present were Supervisor Campbell, Trustees Krumeich, Picarella, Williamson, Miles, Assessor Klopmeier, Highway Commissioner Hessel, Clerk Schulte.

Trustee Picarella led the Pledge of Allegiance.

Motion to approve the minutes of the March 22, 2011 meeting made by Trustee Picarella and seconded by Trustee Williamson. Motion Passed.

Motion to approve the expenditures of Supervisor Campbell and Highway Commissioner Hessel made by Trustee Krumeich and seconded by Trustee Picarella. Motion Passed. Voting "Yes" were Trustees Krumeich, Picarella, Williamson, Miles and Supervisor Campbell.

The Township received a thank-you note from Weber-Rodney Funeral Home for the \$300.00 from General Assistance Fund towards the funeral expenses of Frederica Spindler of Edwardsville Township.

Motion by Trustee Picarella and seconded by Trustee Krumeich to allow the Egyptian Radio Club to use the Township Park over night on June 26, 2011.

Motion by Trustee Miles and seconded by Trustee Williamson for Medical Assistance Catastrophic Insurance at the cost of \$2360.00. Motion Passed. Voting "Yes" were Trustees Krumeich, Picarella, Williamson, Miles and Supervisor Campbell.

Motion to approve Town Board Meeting Schedule, beginning May 1, 2011 through April 30, 2012 made by Trustee Picarella and seconded by Trustee Miles. Motion Passed. Voting "Yes" were Trustees Krumeich, Picarella, Williamson, Miles and Supervisor Campbell.

Supervisor Campbell reported we received the TOIRMA Insurance Invoice in the amount of \$43,073.00. The Township cost is \$22,398.00 and the Road District cost is \$20,675.00. Motion to accept the bid made by Trustee Picarella and seconded by Trustee Williamson. Motion Passed. Voting "Yes" were Trustees Krumeich, Picarella, Williamson, Miles and Supervisor Campbell.

Supervisor Campbell reported the Township received an insurance check in the amount of \$3,552.89 from TOIRMA for storm damage at the Park.

Supervisor Campbell reported Dennis Bush has been hired as a, part-time Park employee.

Highway Commissioner Hessel reported Steve Corbin is new employee for the Road District.

Trustee Williamson presented the Edwardsville Township Attendance Policy. Motion to approve the Attendance Policy made by Trustee Williamson and seconded by Trustee Picarella. Motion Passed. Voting "Yes" were Trustees Picarella, Williamson, Miles and Supervisor Campbell. Voting "No" Trustee Krumeich.

Highway Commissioner Hessel reported when he gets all the easements the work would begin on Old Alton-Edwardsville Road Project.

There being no further business to come before this Board, motion made by Trustee Picarella and seconded by Trustee Williamson to adjourn. Motion Passed.
