

Edwardsville Township Meeting Minutes

June 26, 2012

The meeting of Edwardsville Township was called to order by Supervisor Campbell at 7:00 p.m.

Assessor Klopmeier led the Pledge of Allegiance.

Supervisor Campbell presented the name of Hal Henschen for the vacancy of Edwardsville Township Highway Commissioner. Motion by Trustee Williamson and seconded by Trustee Krumeich to appoint Hal Henschen to fulfill the vacancy of Edwardsville Township Highway Commissioner. Motion Passed. Voting "Yes" were Trustees Krumeich, Picarella, Williamson, Miles and Supervisor Campbell.

Supervisor Campbell asked Clerk Schulte to administer the Oath of Office to Hal Henschen.

Supervisor Campbell asked Clerk Schulte to call the roll. Present were Supervisor Campbell, Trustees Krumeich, Picarella, Williamson, Miles, Assessor Klopmeier, Highway Commissioner Henschen and Clerk Schulte.

Motion to approve the minutes of the May 22, 2012 meeting made by Trustee Williamson and seconded by Trustee Miles. Motion Passed.

Motion to approve the expenditures of Supervisor Campbell and Highway Commissioner Hessel made by Trustee Williamson and seconded by Trustee Picarella. Motion Passed. Voting "Yes" were Trustees Krumeich, Picarella, Williamson, Miles and Supervisor Campbell.

Supervisor Campbell received a thank-you from Assessor Klopmeier for the donation to Oliver Anderson Hospital referring to the passing of her mother.

Supervisor Campbell received annexation notice from the Village of Glen Carbon for the following, Wilfred and Jeannette Brenson 4510 Highway 159 South, Bertha I. Ferrari Trust South State Route 159, Victoria Linksvayer Family Trust 4520 South State Route 159.

Supervisor Campbell introduced new Director Sara Berkbigler and President Bev Meyer of the Main Street Community Center. Director Berkbigler updated the Board on the Community Center's progress. Motion by Trustee Miles and seconded by Trustee Picarella to contribute \$5,000.00 to the Main Street Community Center. Motion Passed. Voting "Yes" were Trustees Picarella, Williamson, Miles and Supervisor Campbell. Trustee Krumeich abstained

Supervisor Campbell introduced John Gibbons and Ann Tosovsky of the Edwardsville Rotary Club. Supervisor Campbell reminded Mr. Gibbons of the Rotary's promise to the

Township that if we allowed them to tear the existing playground down, they would have it rebuilt by the middle of April and that we are approaching July and nothing has been replaced. Supervisor Campbell further stated that the Rotary's actions has caused numerous complaints from citizens that think this was caused by the Township. Mr. Gibbons stated they are trying to get the playground rebuilt through Leathers Company and should receive a call by this Friday (June 29, 2012) and would immediately call Supervisor Campbell with an answer. Mr. Gibbons further stated that is their fault, not the Township's, that this has occurred.

Supervisor Campbell reported Scheffel and Company would perform the Township Audit July 10, 2012.

There being no further business to come before this Board, Motion made by Trustee Miles and seconded by Trustee Picarella to adjourn. Motion Passed.
