Motion Passed. Voting "Yes" were Trustees Krumeich, Picarella, Head, Williamson and Supervisor Miles.

Motion to reluctantly accept the resignation Trustee Picarella after 13 years as a Trustee on the Town Board made by Supervisor Miles and seconded by Trustee Williamson. Motion Passed. Voting "Yes" were Trustees Krumeich, Head, Williamson and Supervisor Miles. Trustee Picarella abstained.

Motion to appoint Danny Picarella as the new Township Highway Commissioner made by Supervisor Miles and seconded by Trustee Williamson. Motion Passed. Voting "Yes" were Trustees Krumeich, Head, Williamson and Supervisor Miles.

Supervisor Miles asked Clerk Schulte to administer the Oath of Office to newly appointed Highway Commissioner Danny Picarella.

Motion to approve Resolution 2014-R15, a resolution terminating the Highway Commissioner's participation in IMRF made by Trustee Williamson and seconded by Trustee Head. Motion Passed. Voting "Yes" were Trustees Krumeich, Head, Williamson and Supervisor Miles.

Motion to approve Resolution 2014-R16, a resolution authorizing a contract with SIUE for Park PAPA intern made by Trustee Head and seconded by Trustee Krumeich. Motion Passed. Voting "Yes" were Trustees Krumeich, Head, Williamson and Supervisor Miles.

Motion to seek an RFP for a Park Master Plan made by Trustee Krumeich and seconded by Trustee Williamson. Motion Passed. Voting "Yes" were Trustees Krumeich, Head, Williamson and Supervisor Miles.

Supervisor Miles reported he received an Engagement Letter from Scheffel Boyle, for the Township Audit. Supervisor Miles referred the letter to Trustee Williamson, action to be taken next month.

Supervisor Miles reported the Township rededicated the Youth Memorial on June 9, 2014 where we also dedicated a tree in honor of past Supervisor Robert Stille. The Township participated in the Route 66 Festival in Edwardsville on June 13 and 14, 2014, where the Township distributed information about Touch a Truck event. The Touch a Truck event, at the Park on June 21, 2014, had 1500 participants attend the event. The Township received notice on June 16, 2014 that we awarded an Illinois Youth Recreation Work Corp Grant from IDNR for youth workers at the Park.

Highway Commissioner Henschen stated the project on Grand Avenue has started'
