Supervisor Miles distributed a letter from the Village of Glen Carbon, a meeting notice re: Joint Review Board of Tax Increment Finance District #1 of Glen Carbon.

Supervisor Miles distributed a letter, he wrote, requesting assistance for a new building for the Township to State Representative Dwight Kay and State Senator Bill Haine with copies to U.S. Representative Rodney Davis, U.S. Senator Dick Durbin and U.S. Senator Mark Kirk. This was mainly directed at the state legislators in anticipation of any proposed or potential Capital Bill that would be passed in Springfield and letting them know the Township's needs.

Supervisor Miles reported Trustee Head is no longer able to serve on the Main Street Community Center Board. He appointed Christine Doty, of the office, to fill that role. Supervisor Miles thanked everyone for their participation in the Halloween Parade and to the Highway Commissioner Staff who help with the transportation, development and storage of our float. Our float, which depicted the U.S. Navy A7 Corsair in the Park, took home First place the non-profit division. A big thanks to Park Intern Mary Castillo for designing and constructing the float. All striping on the tennis courts is complete, including striping one court with pickle ball stripes. We will be getting new tennis nets soon.
