

**ORDINANCE NO. 2016-O06**

**AN ORDINANCE SETTING COMPENSATION OF TOWNSHIP OFFICIALS  
FOR THE FOUR YEAR TERM BEGINNING MAY 15, 2017,  
EDWARDSVILLE TOWNSHIP, MADISON COUNTY, ILLINOIS**

**WHEREAS**, according to 60 ILCS 1/65-20, the compensation of township officers shall be set by the township board at least 180 days before the beginning of the terms of office.

**WHEREAS**, according to 60 ILCS 1/65-20, the compensation for the road district treasurer shall be fixed by the township board and shall be not less than \$100 or more than \$1,000 per year.

**WHEREAS**, according to 605 ILCS 5/6-207, the compensation of the highway commissioner shall be fixed by the township board at an annual salary of not less than \$3,000 to be paid in equal monthly installments, or a per diem amount for each day he or she is necessarily employed in the discharge of official duties;

**WHEREAS**, according to 35 ILCS 200/2-70, the compensation of the township assessor shall be set by the township board at the same time the board sets the compensation of its township supervisor.

**NOW, THEREFORE, BE IT ORDAINED** by the Township Board of Edwardsville, Madison County, Illinois that the compensation of the township officials for the four year term beginning May 15, 2017 and ending May 17, 2021 (January 1, 2018 – January 1, 2022 for assessors and collectors) shall be as follows:

**SECTION 1:** That the salaries for township officials shall be as follows:

**Supervisor's Salary: Effective for each of the following years:**

May 15, 2017 – May 21, 2018 - \$25,000.00	May 21, 2018 – May 20, 2019 - \$25,000.00
May 20, 2019 – May 19, 2020 - \$25,000.00	May 19, 2020 – May 17, 2021 - \$25,000.00
Road District Treasurer:	\$1,000.00 ANNUALLY

**Township Clerk: Effective for each of the following years:**

May 15, 2017 – May 21, 2018 - \$6,200.00	May 21, 2018 – May 20, 2019 - \$6,200.00
May 20, 2019 – May 19, 2020 - \$6,200.00	May 19, 2020 – May 17, 2021 - \$6,200.00

**Trustees: Effective for each of the following years:**

May 15, 2017 – May 21, 2018 - \$208.00 per monthly board meeting attended
May 21, 2018 – May 20, 2019 - \$208.00 per monthly board meeting attended
May 20, 2019 – May 19, 2020 - \$208.00 per monthly board meeting attended
May 19, 2020 – May 17, 2021 - \$208.00 per monthly board meeting attended

**Assessor: Effective for each of the following years:**

January 1, 2018 – January 1, 2022
2018 - \$60,405.80      2019 - \$60,405.80      2020 - \$60,405.80      2021 - \$60,405.80

**Highway Commissioner: Effective for each of the following years:**

May 15, 2017 – May 21, 2018 - \$29,000.00	May 21, 2018 – May 20, 2019 - \$29,000.00
May 20, 2019 – May 19, 2020 - \$29,000.00	May 19, 2020 – May 17, 2021 - \$29,000.00

**SECTION 2:** That the following township officials in addition to the compensation outlined in Section 1, will receive the following benefits:

Assessor: IMRF

**SECTION 3:** That annual salaries shall be paid bi-monthly in 24 installments each year. Trustees shall be paid on the 15<sup>th</sup> of the month for attendance at the prior month's board meeting.

**SECTION 4:** That employer contributions and appropriate withholdings from said compensation shall be made by Edwardsville Township and filed for such elected officials when and as may be required from time to time during their respective term of office for federal and state income taxes, federal Social Security, Medicare and Medicaid taxes, and any other proper and lawful withholdings as required by law and/or as designated by the elected official during the term of office.

**SECTION 5:** That any township official named above may participate in township sponsored insurance programs including, but not limited to health, life, dental, and vision at the sole cost of the official.




**SECTION 6:** That if any section, paragraph or provision of this Ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this Ordinance.

**SECTION 7:** That all prior Ordinances and Resolutions in conflict or inconsistent herewith are hereby expressly repealed only to the extent of such conflict or inconsistency.

**SECTION 8:** That this ordinance shall be in full force and effect on May 15, 2017, as provided by law.
