

RESOLUTION NO. 2017-R17

A RESOLUTION AUTHORIZING A TRANSFER OF APPROPRIATIONS
FOR THE PERMANENT ROAD FUND

WHEREAS, there was adopted on the 26TH day of April, 2016, by the Board of Trustees of Edwardsville Township, Madison County, Illinois a Budget & Appropriation Ordinance for the fiscal year beginning April 1, 2016 and ending March 31, 2017; and

WHEREAS, it now appears that certain adjustments between appropriated line items in the Permanent Road Fund in said ordinance are desirable and necessary; and

WHEREAS, Section 3 of the Illinois Municipal Budget Law (50 ILCS 330/3), as approved July 12, 1937, as amended, authorizes transfer between the various line items within any fund in such Appropriation Ordinance not exceeding 10% of the total amount appropriated in such fund by such ordinance.

NOW, THEREFORE, BE IT RESOLVED by the Township Board of Edwardsville, Madison County, Illinois as follows:

SECTION 1: That there is hereby transferred from the unexpended balance of the line item **Contingencies** in the **Permanent Road Fund Seventy Dollars and Zero Cents (\$70.00)** which transferred sum is hereby added to the line item **Employment Screening** in the same fund, making the adjusted appropriation for the first line item aforesaid **Fourteen Thousand Nine Hundred Thirty Dollars and Zero Cents (\$14,930.00)**, and the second line item aforesaid **One Thousand Seventy Dollars and Zero Cents (\$1,070.00)**.

SECTION 2: That there is hereby transferred from the unexpended balance of the line item **Contingencies** in the **Permanent Road Fund Two Hundred Fifty Dollars and Zero Cents (\$250.00)** which transferred sum is hereby added to the line item **Work Comp Insurance** in the same fund, making the adjusted appropriation for the first line item aforesaid **Fourteen Thousand Six Hundred Eighty Dollars and Zero Cents (\$14,680.00)**, and the second line item aforesaid **Nine Thousand Seven Hundred Fifty Dollars and Zero Cents (\$9,750.00)**.

Motion was made by TRUSTEE Fuhler, seconded by TRUSTEE Williamson
that the Resolution be adopted and approved by 4 Ayes and 0 Nays.
