A RESOLUTION AMENDING RESOLUTION NO. 2017-R06 WHICH AUTHORIZED A CONTRACT WITH SOUTHERN ILLINOIS UNIVERSITY OF EDWARDSVILLE

WHEREAS, Edwardsville Township, Madison County, Illinois, is a Township operating under and pursuant to the Illinois Township Code; and

WHEREAS, Edwardsville Township wishes to provide students of Southern Illinois University Edwardsville a valuable and practical learning experience in township government through a graduate assistantship program; and

WHEREAS, the Township Board passed Resolution 2017-R06 on February 28, 2017 which authorized a contract with the Board of Trustees of Southern Illinois University to employ one graduate assistant through the Department of Public Administration and Policy Analysis from May 16, 2017 to August 15, 2017 at the total cost of \$3,750.00; and

WHEREAS, Edwardsville Township wishes to extend the above contract from August 15, 2017 to May 15, 2018.

NOW, THEREFORE, BE IT RESOLVED by the Township Board of Edwardsville, Madison County, Illinois as follows:

SECTION 1: The above cited recitals are incorporated herein by reference.

SECTION 2: The Board of Trustees of Edwardsville Township will extend the above referenced contract with the Board of Trustees of Southern Illinois University to employ one graduate assistant through the Department of Public Administration and Policy Analysis to May 15, 2018.

SECTION 3: The Board of Trustees of Edwardsville Township will agree to pay an additional \$11,250.00, increasing the agreement from \$3,750.00 to \$15,000.

Motion was made by TRUSTEE CHAPMAN, seconded by TRUSTEE SCHMIDT that the Resolution be adopted and approved by 4 Ayes and 1 Nays.


