

RESOLUTION NO. 2018-R12

A RESOLUTION AUTHORIZING A SERVICE CONTRACT  
WITH EDWARDSVILLE ROTARY

**WHEREAS**, The Board of Trustees of Edwardsville Township wishes to provide residents of the Township with safe recreation opportunities and has partnered successfully with Edwardsville Rotary in the past to provide some of those opportunities; and

**WHEREAS**, the Edwardsville Rotary Criterium has become one of the community's largest and most well-attended signature Edwardsville Glen Carbon events attracting nearly 300 cyclists from nine states, 200 local volunteers and thousands of spectators; and

**WHEREAS**, Section 60 ILCS 1/85-13 of the Illinois Compiled Statutes permits Townships to enter into contractual relationships with a non-profit organization to provide recreation services; and

**WHEREAS**, the Edwardsville Rotary will host the Edwardsville Rotary Criterium, a series of high-speed amateur and professional bicycle races, free kids races, and live bands, in Edwardsville, Illinois on August 18, 2018.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Board of Edwardsville, Madison County, Illinois as follows:

**SECTION 1:** That the Board of Trustees of Edwardsville Township will enter into a service contract with the Edwardsville Rotary to sponsor the public safety components of the Edwardsville Rotary Criterium, including the safety barricades, supplemental EMT station on the race course, and the supplemental safety and event security personnel around the perimeter of the course.

**SECTION 2:** That the Board of Trustees of Edwardsville Township will agree to pay a total of \$5,000.00 due August 18, 2018.

Motion was made by Krumbech, seconded by Schmidt  
that the Resolution be adopted and approved by Four (4) Ayes and Zero (0) Nays.




This contract is by and between the Board of Trustees of Edwardsville Township hereinafter referred to as "Edwardsville Township" and the Rotary Club of Edwardsville hereinafter referred to "Edwardsville Rotary" agree as follows:

1. The term of this contract is specifically for the Edwardsville Rotary Criterium on August 18, 2018.
2. The Rotary agrees to:
  - (a) Host the Edwardsville Rotary Criterium on August 18, 2018;
  - (b) Provide residents of Edwardsville and Glen Carbon with safer recreational activities including high-speed bicycle races, free kids races and activities, and food concessions;
  - (c) Recognize Edwardsville Township as a Presenting Public Safety Sponsor of the event and provide the following benefits: Edwardsville Township will be allowed to set up an information booth at the Criterium free of charge to promote its programs and special projects. The Edwardsville Township name and logo will appear at the Start/Finish Line and on Race-Day Promos, Race Posters displayed throughout the community, Mesh Banners and two bale signs displayed on the race course, the Criterium website, and on the Race Day Map.
  - (d) Provide a 20x20 tent, 20 chairs, and 4 tables in the tent at a mutually agreed upon location. There will be space behind the tent for two supply vans from Cardinal Glennon.
3. Edwardsville Township agrees to:
  - (a) Support the public safety components of the Criterium for the safety of the Criterium participants, crews, and spectators, to include the rental and set up of the race course barricades, the supplemental EMT presence on the course, and the supplemental safety and event security personnel around the perimeter of the course.
  - (b) Partner with Cardinal Glennon to provide properly fitted bike helmets and new bike helmets (while supplies last) to kids of Edwardsville Township.
  - (b) Pay to the Edwardsville Rotary a total of \$5,000 due by August 18, 2018.
4. In the event that the Edwardsville Rotary Criterium is unable to be held, the Edwardsville Rotary will refund the total amount paid by Edwardsville Township.
