

RESOLUTION NO. 2018-R13

**A RESOLUTION AUTHORIZING THE SALE AND DISPOSAL OF
CERTAIN TOWNSHIP PERSONAL PROPERTY**

WHEREAS, Edwardsville Township, Madison County, Illinois, is a Township operating under and pursuant to the Illinois Township Code; and

WHEREAS, the Township owns several items of personal property and equipment; and

WHEREAS, the Illinois Township Code, 60 ILCS 1/30-50, provides that the Township Board of Trustees may decide to dispose of personal property by a vote of the Township Board; and

WHEREAS, Section 30-50 provides the Township Board has the option of either selling the personal property through an auction (either in person or online) or through a personal property sale notice and bid process; and.

WHEREAS, the Highway Commission has identified certain property that is no longer needed or useful to the Township and that should be sold, including namely a Case HI Tractor 105U 4WD (#ZAJL07531), Case HI Tractor 105U 4WD (#ZAJL07381), Woods Brushbull Mower BB840 (#1047172), and Woods Brushbull Mower BB840 (#1047169); and

WHEREAS, the Township Board desires to adopt this resolution to authorize the sale and disposition of the itemized property currently maintained by the Road District.

NOW, THEREFORE, BE IT RESOLVED by the Township Board of Edwardsville, Madison County, Illinois as follows:

SECTION 1: The above cited recitals are incorporated herein by reference.

SECTION 2: The Township Board hereby declares that following personal property of the Township is no longer needed or useful and should be sold by the Township: Case HI Tractor 105U 4WD (#ZAJL07531), Case HI Tractor 105U 4WD (#ZAJL07381), Woods Brushbull Mower BB840 (#1047172), and Woods Brushbull Mower BB840 (#1047169).

SECTION 3: The Township Board authorizes the personal property set forth in Section 2 to be sold through a personal property sale notice and bid process.

SECTION 4: In the event of a conflict between the terms of this Resolution and any other Resolution of the Township the terms of the Resolution shall govern.

SECTION 5: In the event that any term or provision hereof is found or determined to be invalid, the invalid portion shall be deemed stricken here from and the remainder shall be in full force and effect.

SECTION 6: This resolution shall be in full force and effect immediately after its passage and approval.
