

**RESOLUTION NO. 2019-R27**

**A RESOLUTION AUTHORIZING AN INTERGOVERNMENTAL AGREEMENT  
BETWEEN EDWARDSVILLE TOWNSHIP AND  
EDWARDSVILLE TOWNSHIP ROAD AND BRIDGE**

THIS AGREEMENT is entered into by and between the Edwardsville Township of Madison County, Illinois, herein “the Township”, and the Edwardsville Township Road and Bridge of Madison County, herein “the Township Road and Bridge” of Madison County, Illinois.

WHEREAS the Township and the Township Road and Bridge wish to enter into a cooperative agreement for a shared employee; and

WHEREAS, the 1970 Illinois Constitution (Art. VII. Sec. 10) and the Illinois Compiled Statutes 5 ILCS 220/3 of the Illinois Compiled Statute, provides that any power or powers, privileges, functions, or authority exercised or which may be exercised by a unit of local government may be exercised and enjoyed jointly with any other unit of local government; and

NOW, THEREFORE, in consideration of the mutual covenants contained in this Agreement, the Township and the Township Road & Bridge agree as follows:


- 1. Sharing of a Full-Time Employee.** The Township Road & Bridge and the Township agree to share a full-time employee who will serve the Township Park and the Township Road & Bridge on an as-needed basis, to assist with snow removal during inclement weather and other assignments as necessary. As part of this Agreement, the Township Road & Bridge will reimburse the Township Park for hours the full-time park employee works for the Township Road & Bridge. The Township will pay IMRF, Social Security, and Health Insurance benefits, vacation, personal and sick days, and other benefits of full-time employment for said employee upon the employee’s eligibility, with benefit structure subject to change. Employee will be bound by the Personnel Policies established by and pertaining to employees with the Township/Township Road and Bridge

per Township Park employee policies, and will report to the Township Supervisor, with oversight by the Park Manager and the Edwardsville Township Administrator to perform duties for the Township, and the Township Road & Bridge Highway Commissioner to provide oversight for duties falling under the Township Road & Bridge purview, at the rate of pay determined by the Township Supervisor.

1. **Binding Agreement.** This Agreement shall be construed by the parties as a permanent and binding agreement between the Township and the Township Road & Bridge; shall continue between the parties during the tenure of employment; and may be amended only upon agreement of both parties.
