

**ROAD AND BRIDGE RESOLUTION NO. 2019-R04**

**A RESOLUTION AUTHORIZING THE SALE AND DISPOSAL OF  
CERTAIN EDWARDSVILLE TOWNSHIP ROAD AND BRIDGE PERSONAL PROPERTY**

**WHEREAS**, Edwardsville Township Road and Bridge, Madison County, Illinois, is a Township operating under and pursuant to the Illinois Township Code; and

**WHEREAS**, the Edwardsville Township Road and Bridge, herein after referred to as the Township Road and Bridge, owns several items of personal property and equipment; and

**WHEREAS**, the Illinois Township Code, 60 ILCS 1/30-50, provides that the Township Board of Trustees may decide to dispose of personal property by a vote of the Township Board; and

**WHEREAS**, Section 30-50 provides the Township Board has the option of either selling the personal property through an auction (either in person or online) or through a personal property sale notice and bid process, or disposing of said property; and

**WHEREAS**, the Highway Commissioner has identified certain property that is no longer needed or useful to the Township Road and Bridge and that should be disposed of, including namely several pieces of office equipment; and

**WHEREAS**, the Township Board desires to adopt this resolution to authorize the disposition of the itemized property currently maintained by the Township Road and Bridge.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Board of Edwardsville, Madison County, Illinois as follows:

**SECTION 1:** The above cited recitals are incorporated herein by reference.

**SECTION 2:** The Township Board hereby declares that following personal property of the Township Road and Bridge is no longer needed or useful and should be disposed of by the Township Road and Bridge:

**SECTION 5:** In the event that any term or provision hereof is found or determined to be invalid, the invalid portion shall be deemed stricken here from and the remainder shall be in full force and effect.

**SECTION 6:** This resolution shall be in full force and effect immediately after its passage and approval.
