AN ORDINANCE LEVYING TAXES FOR ALL TOWN PURPOSES  
FOR EDWARDSVILLE TOWNSHIP, MADISON COUNTY, ILLINOIS  
FOR THE TAX YEAR 2019, COLLECTABLE IN 2020

**BE IT ORDAINED** by the Board of Trustees of Edwardsville Township, Madison County, Illinois as follows:

**SECTION 1:** That the sum of **eight-hundred-fifty-three thousand five-hundred dollars and 00/100 dollars (\$853,500.00)** are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

General Town Fund  
Illinois Municipal Retirement Fund  
Social Security Fund  
General Assistance Fund

for the year 2019.

**SECTION 2:** That the amount levied for each object and purpose shall be as follows:




