Edwardsville Township Meeting Minutes

January 22, 2020

Draft February 26, 2020

The meeting of the Edwardsville Township Board was called to order by Supervisor Schulte at 7:00 P. M. at the Glen Carbon Village Hall, 151 N. Main St., Glen Carbon, Illinois. Present were Supervisor Schulte, Trustees Chapman, Hall, Schmidt, Duame, Assessor Klopmeier, Highway Commissioner Picarella, and Clerk Schwind.

Highway Commissioner Picarella led the Pledge of Allegiance.

PRESENTATION: Highway Commissioner Picarella presented the annual MS4 Storm Water Program update. Data was presented regarding storm water runoff, and the Christmas tree and tire recycling programs. Every four years, Madison County Planning and Development's Storm Water Management and the Illinois Environmental Protection Agency conduct an audit of program delivery. The audit was completed earlier in the week. Highway Commissioner Picarella reported the findings would be available within the next 4-6 weeks.

PUBLIC COMMENT: None

CONSENT AGENDA: Motion to approve the Consent Agenda, including the minutes for the December 18, 2019 meeting; the authorization of expenditures from December 7, 2019 – January 10, 2020, and the revised list of bills made by Trustee Schmidt, seconded by Trustee Duame. Motion Passed. Voting "Yes"—Trustees Chapman, Hall, Schmidt, Duame and Supervisor Schulte.

CORRESPONDENCE: The Madison County Zoning Board of Appeals Public Hearing Notice for Tuesday, January 28, 2020 was distributed.

The Edwardsville Township Assessor's 2020-2021 Budget, which was prepared by the Assessor, was provided to the board for review. The Township Clerk will file the annual budget in the Township office.

Supervisor Schulte provided the annual Statement of Economic Interest filing notice from the Madison County Clerk's office. The notice states that soon, letters will be sent to Township elected officials' homes and Township email accounts with filing instructions and a deadline for compliance.

Supervisor Schulte provided a "Thank You" letter from the Nurses of Edwardsville CUSD #7, acknowledging the Township for again donating holiday baskets to families in need. The baskets were distributed to five ECUSD #7 schools.

COMMITTEE REPORTS: Trustee Chapman, chair of the Facilities Planning Committee, reported Jamie Henderson of Henderson Associates Architects will be coordinating the examination of the sink hole on the Town Hall site with Highway Commissioner Picarella's crew. Excavation and geotechnical work is expected to begin within the next 30 days. Mr.

Henderson is also working with the City of Edwardsville to determine the future of Johnson Street parking.

Motion Passed. Voting "Yes"—Trustees Chapman, Hall, Schmidt, Duame, and Supervisor Schulte.

Motion to Pass Resolution No. 2020-R04 Authorizing Edwardsville Township to Seek Madison County Resource Management Program Environmental Grant Funding Not to Exceed \$15,000 was made by Trustee Hall, seconded by Trustee Schmidt. SUPERVISOR'S COMMENTS: Supervisor Schulte reported the first Lunch and Learn Workshop of 2020 was held January 15 at Main Street Community Center. The meet and greet format was well attended, with more than 30 participants. The next Lunch and Learn event will take place Wednesday, February 19, 2020 at Wang Gang Asian Eats in Edwardsville. The topic will be Foster Care and Adoption.

A tennis clinic hosted by the Edwardsville High School Tennis Team, organized by Coach David Lipe, will take place from 10-11 a.m. Monday, April 6, 2020 at Edwardsville Township Community Park.

According to a statement provided by First Mid Bank and Trust, Supervisor Schulte reported a total of \$52,143.56 in interest was earned on Permanent Road CD accounts in 2019.

HIGHWAY COMMISSIONER'S COMMENTS: Highway Commissioner Picarella reported snow removal has gone well so far. He has received several compliments from residents. The Township Road and Bridge currently has about 500 tons of salt in reserve.

Highway Commissioner Picarella reported a total of 398 trees have been recycled as part of the Madison County Christmas Tree Recycling Program.

Highway Commissioner Picarella reported TMW is working on drainage along Frisby Road in Edwardsville.

TOWNSHIP ASSESSOR COMMENTS: Assessor Klopmeier reported nearly 3,000 senior property tax homestead exemption and freeze forms were sent January 15, 2020 to seniors residing in Edwardsville Township. Nearly 300 of the letters were sent to seniors living in mobile homes.
