Edwardsville Township Meeting Minutes

April 22, 2020

Draft May 27, 2020

The meeting of the Edwardsville Township Board was called to order by Supervisor Schulte at 7:02 P. M. at the Glen Carbon Village Hall, 151 N. Main St., Glen Carbon, Illinois. Present were Supervisor Schulte, Trustees Chapman, Hall, Schmidt, Duame, Assessor Klopmeier, Highway Commissioner Picarella, and Clerk Schwind. Trustees Chapman, Hall, and Schmidt, Assessor Klopmeier and Highway Commissioner Picarella were connected to the meeting remotely.

Trustee Schmidt led the Pledge of Allegiance.

PRESENTATION: None

PUBLIC HEARING: Budget and Appropriation Ordinance for Edwardsville Township. No members of the public presented for comment. Motion to close public hearing was made by Trustee Duame, seconded by Trustee Chapman. Motion passed. Voting “Yes”—Trustees Chapman, Hall, Schmidt, Duame, and Supervisor Schulte.

Budget and Appropriation Ordinance for Edwardsville Township Road and Bridge. No members of the public presented for comment. Motion to close public hearing was made by Trustee Duame, seconded by Trustee Schmidt. Motion Passed. Voting “Yes”—Trustees Chapman, Hall, Schmidt, Duame and Supervisor Schulte

PUBLIC COMMENT: None

CONSENT AGENDA: Motion to approve **the Consent Agenda, including the minutes for the March 25, 2020 meeting; the authorization of expenditures from March 14, 2020 – April 10, 2020, and the revised list of bills** was made by Trustee Chapman, seconded by Trustee Hall. Motion Passed. Voting “Yes”—Trustees Chapman, Hall, Schmidt, Duame and Supervisor Schulte.

CORRESPONDENCE: The Madison County Circuit Clerk Fine’s Report for March 2020 was distributed. There were no fines collected for Edwardsville Township.

The Madison County Treasurer released the Final Settlement Sheet for 2018 Real Estate Taxes and 2019 Mobile Home Taxes. The report was distributed. Correspondence from the Treasurer’s office indicated tax bills for 2019 and mobile home bills for 2020 will be mailed the first week of June, 2020. Property tax due dates for 2020 will be July 9, September 9, October 9, and December 9. The correspondence further stated due to the COVID-19 pandemic, late payment penalties will be waived through the second installment due date, September 9, 2020.

Correspondence was distributed indicating the IMRF Preliminary Notice of Contribution Rate for 2021 will be 14.02 percent. This is lower than the 2020 rate.

A Thank You Letter was received from Main Street Community Center for the Edwardsville Township Board contribution of \$1,200 for pandemic response. The money was used to purchase food for delivery to homebound area seniors.

ACTION ITEMS: Motion to approve Resolution No. 2020-R10 Authorizing a Transfer of Appropriations (Town Fund) from Contingencies to Supervisor Dues & Subscriptions; from Assessor Contingencies to Assessor Training, and from Assessor Contingencies to Assessor Office Supplies. Motion was made by Trustee Hall, seconded by Trustee Duame. Motion Passed. Voting “Yes”—Trustees Chapman, Hall, Schmidt, Duame, and Supervisor Schulte.

Motion to approve Resolution No 2020-R-11 Authorizing a Transfer of Appropriations (General Assistance) from Contingencies to Food & Personal Assistance. Motion was made by Trustee Schmidt, seconded by Trustee Hall. Motion Passed. Voting “Yes”—Trustees Chapman, Hall, Schmidt, Duame, and Supervisor Schulte.

Motion to approve Road and Bridge Resolution No 2020 -R02 Authorizing a Transfer of Appropriations (Road) from Contingencies to Printing and Publishing. Motion was made by Trustee Hall, seconded by Trustee Duame. Motion Passed. Voting “Yes”—Trustees Chapman, Hall, Schmidt, Duame, and Supervisor Schulte.

Motion to approve Road and Bridge Resolution No 2020 -R03 Authorizing a Transfer of Appropriations (Perm Road) from Contingencies to Waste Management. Motion was made by Trustee Schmidt, seconded by Trustee Hall. Motion Passed. Voting “Yes”—Trustees Chapman, Hall, Schmidt, Duame, and Supervisor Schulte.

Motion to pass Ordinance No 2020 -RO01 FY2020-21 Budget & Appropriations for Edwardsville Township. Motion was made by Trustee Chapman, seconded by Trustee Duame. Motion passed. Voting “Yes” —Trustees Chapman, Schmidt, Duame and Supervisor Schulte. Voting “No” – Trustee Hall.

Motion to pass Ordinance No 2020 -RO1 FY2020-21 Budget & Appropriations for Edwardsville Township. Motion was made by Trustee Duame, seconded by Trustee Schmidt. Motion Passed. Voting “Yes”—Trustees Chapman, Hall, Schmidt, Duame, and Supervisor Schulte.

NEW BUSINESS: Discussion ensued concerning Edwardsville Township’s response to the COVID-19 pandemic and the allocation of resources to partner agencies to assist in the community response. Members of the board also collectively acknowledged the hard work and dedication of first responders during the pandemic.

OLD BUSINESS: None

SUPERVISOR'S COMMENTS: Supervisor Schulte reported Administrator Behrhorst and Community Outreach Coordinator Doty having been working in the office and remotely during the pandemic, with at least one in the office each day of the work week. Administrator Behrhorst has been working in the office Mondays-Wednesdays and remotely Thursdays and Fridays. Community Outreach Coordinator Doty has been working remotely Mondays and Tuesdays and in the office Wednesdays-Fridays.

As directed by Southern Illinois University Edwardsville, the graduate interns working through the Supervisor's office have been managing tasks and maintaining their 20-hour per week schedules from home. Among myriad projects they have been assigned, they have worked to update the Township website and create a COVID-19 community resource page, as well as post community resources on the Township's Facebook pages.

Road Secretary/Park Manager Carrie Gill has been working her normal schedule remotely. Park Maintenance Worker Trevor Hubbard has been working 40 hours each week, Monday-Friday, at the Park. The Park remains closed. All reservations have been refunded for April events and May events have been cancelled.

Supervisor Schulte reported the annual filing of the Statement of Economic Interest is due in the Madison County Clerk's office by May 1. He advised board members to contact Administrator Behrhorst at the Edwardsville Township office during normal business hours if they need help completing the requirement.

It was reported that Edwardsville Township continues to share federal, state, and local COVID-19 pandemic resource information through social media. Supervisor Schulte stated that in light of state and local governments slowing or ceasing operations during this time, the Supervisor's office has compiled a shared Google document to maintain a running list of those requesting assistance. The office is managing requests by phone, email, and social media as they come in, leading people to resources that are available to meet specific needs. So far, there are more than seventy people on the list, many with more than one need. He noted starting Monday, April 27, 2020, Madison County will resume accepting Illinois Home Energy Assistance Program (IHEAP) for low-income individuals needing help with utility bills. The Township will begin assisting with applications remotely at that time.

Supervisor Schulte reported that per gubernatorial order, due to the COVID-19 pandemic the Annual Town Hall Meeting scheduled for Tuesday, April 14, 2020, was delayed until further notice.

HIGHWAY COMMISSIONER'S COMMENTS: Edwardsville Township Highway Commissioner Danny Picarella reported the Old Alton Road bid package is being coordinated with Edwardsville Township Attorney Tonya Genovese and an outside firm.

Highway Commissioner Picarella also reported a used bucket truck for the Edwardsville Township Road and Bridge District has been purchased for \$29,900.

The Road and Bridge crew is maintaining CDC guidelines for safe work practices and only one employee is allowed to be a vehicle at any time. Highway Commissioner Picarella reported if any employee is uncomfortable with any procedure, they have been instructed to contact him immediately.

TOWNSHIP ASSESSOR COMMENTS: Supervisor Schulte read Assessor Klopmeier's comments to the board. The report from the Assessor indicated today marked the deadline for multiplier appeals to the Property Tax Appeal Board in Springfield, Illinois.

It was also noted the Assessor's staff is working mostly remotely and will continue to do so into the foreseeable future during the COVID-19 pandemic. Each staff member works from the Assessor's office at least one each week.

EXECUTIVE SESSION: None

ADJOURNMENT: There being no further business to come before the board, motion was made by Trustee Duame, seconded by Trustee Hall to adjourn. Motion passed at 7:58 p.m.
