The meeting of the Edwardsville Township Board was called to order by Supervisor Schulte at 7:08 p.m. at the Glen Carbon Village Hall, 151 N. Main St., Glen Carbon, Illinois. Physically present were Supervisor Schulte, Trustee Duame, Highway Commissioner Picarella, and Clerk Schwind. Trustees Chapman, Hall, Schmidt, and Assessor Klopmeier were connected to the meeting remotely.

Trustee Hall led the Pledge of Allegiance.

PUBLIC COMMENT: None

CONSENT AGENDA: Motion to approve the Consent Agenda, including the minutes for the April 22, 2020 meeting; the authorization of expenditures from April 11, 2020 – May 15, 2020, and the revised list of bills made by Trustee Duame, seconded by Trustee Schmidt. Motion Passed. Voting "Yes"—Trustees Chapman, Hall, Schmidt, Duame and Supervisor Schulte.

CORRESPONDENCE: The Madison County Circuit Clerk Fine's Report for April 2020 was distributed. There were no fines collected for Edwardsville Township.

A Notice of Grant Award from the Trees Forever Illinois Recover, Replant & Restore program was distributed to the Board. Edwardsville Township secured an award for \$700 through the program to purchase and plant trees at Edwardsville Township Community Park.

The Madison County Zoning Board of Appeals Public Hearing notice was distributed. A virtual public hearing was held Tuesday, June 9, 2020.

Motion to pass Resolution No2020-R-13 Committing Local Funds for the Renovation and Expansion of Edwardsville Town Hall Facility (Rebuild Illinois Grant Application) was made by Trustee Duame, seconded by Trustee Schmidt. Motion Passed. Voting "Yes"—Trustees Chapman, Hall, Schmidt, Duame, and Supervisor Schulte.

OLD BUSINESS: None

SUPERVISOR'S COMMENTS: Supervisor Schulte reported Edwardsville Township Community Park currently is closed in accordance with the Governor's Executive Order in response to the COVID-19 pandemic. The Supervisor's office refunded park patrons for all pavilion reservations at the Park through the month of May. In other Park business, Supervisor Schulte noted the grills at Park pavilions have been repaired by Rae's, a company based in Edwardsville. He also noted several applications have been received for open Park Maintenance Worker positions. Two candidates have been interviewed.

Supervisor Schulte reported the plan is to have the Supervisor and Assessor's office staff back in the Town Hall, 300 West Park Street, Edwardsville, Illinois working regular hours Monday through Friday as of June 1, 2020. The SIUE MPA interns will continue working remotely from home until they are released by the University to return to the physical office. Supervisor Schulte stated the interns have been essential to the Township during the pandemic. They have been scheduling IHEAP appointments, assisting with grant applications, refining documents, updating the website, and fielding messages through social media and emails.

Supervisor Schulte reported Graduate Intern Stephanie Cuvar's last day was Friday, May 15. She is now completing a required internship for the second part of her master's degree through museum studies. He noted she was an asset to the Township's team, and she is very much missed. Ms. Cuvar's replacement, Graduate Intern Alan Ayala, started Monday, May 18. It was reported he is acclimating well to his new role.

HIGHWAY COMMISSIONER'S COMMENTS: Highway Commissioner Picarella reported the Edwardsville Township Road and Bridge district is expecting to receive 10 bid packages for the planned Old Alton Road project. The bid opening will take place at 10:30 a.m. Thursday, May 28, 2020.

Highway Commissioner Picarella reported the road crew has been clearing trees from recent storms. The recently purchased bucket truck has been useful in this work. The crew has completed pouring handicapped-accessible concrete pads at park pavilions and painted clear coat in bathrooms.

 - a. The meeting was called to order at 9:07 a.m. by Chairman Matt Chapman via Zoom.
