**OLD BUSINESS: None** 

SUPERVISOR'S COMMENTS: Supervisor Schulte reported Edwardsville Township Community Park remains closed in response to the COVID-19 pandemic. The Supervisor's office refunded park patrons for all pavilion reservations at the Park through the month of June. He reported all remaining work to bring the Park to full ADA compliance is nearly complete. Handicapped-accessible grills are being placed, concrete pads are being poured, and handicapped-accessible parking spaces are being added and graded.

Supervisor Schulte reported the Town Hall located at 300 West Park Street, Edwardsville, Illinois will open to the public again Monday, June 29, 2020. Employees are being required to sign a certification that they have not had any COVID-19 symptoms during the last 14 days.

It was noted that Madison County property tax bills were sent out at the beginning of June. Supervisor Schulte stated there is a two-month grace period on the first installment, which means taxpayers have until September 9, 2020 to pay the first and second property tax installments without a penalty.

According to the final computation report for the 2019 tax year, payable in 2020, Supervisor Schulte reported Edwardsville Township's rate-setting equalized assessed valuation (EAV) was \$1,075,816,740 and the Township's tax rate was set at 0.0796. This reflects eight-tenths of an increase in the rate from 2018.

HIGHWAY COMMISSIONER'S COMMENTS: Highway Commissioner Picarella reported the Edwardsville Township Road and Bridge district received 8 bid packages for the planned Old Alton/Edwardsville Road project. The bid was awarded to Haier Plumbing at \$69,944.
