Edwardsville Township Meeting Minutes

Wednesday, July 22, 2020

The meeting of the Edwardsville Township Board was called to order by Supervisor Schulte at 7 p.m. at the Glen Carbon Village Hall, 151 N. Main St., Glen Carbon, Illinois. Present were Supervisor Schulte, Trustees Hall, Schmidt, and Duame, Clerk Schwind, and Highway Commissioner Picarella. Absent were Trustee Chapman and Assessor Klopmeier.

Trustee Hall led the Pledge of Allegiance.

PRESENTATION: None

PUBLIC HEARING: None

PUBLIC COMMENT: None

CONSENT AGENDA: Motion to approve the Consent Agenda, including the minutes for the June 24, 2020 meeting; the authorization of expenditures from June 13, 2020 – July 10, 2020, and the revised list of bills made by Trustee Schmidt, seconded by Trustee Duame. Motion Passed. Voting "Yes"—Trustees Hall, Schmidt, Duame and Supervisor Schulte.

CORRESPONDENCE: The Madison County Circuit Clerk Fine's Report for June 2020 was distributed. There were no fines collected for Edwardsville Township.

Notice was distributed to the board concerning two Madison County Zoning Board of Appeals Public Hearings. One hearing was held July 14, 2020 and it was reported the other is scheduled to take place July 28, 2020.

Notice of Proposed Annexation of Territory within Edwardsville Township to the Village of Glen Carbon was distributed to the board. The Village of Glen Carbon also mailed proposed annexation notices to board members' residences.

OLD BUSINESS: None

SUPERVISOR'S COMMENTS: Supervisor Schulte reported after being closed due to the pandemic, Edwardsville Township Community Park reopened July 20, 2020. He noted signs were posted in several locations at the park notifying patrons of new guidelines in compliance with recommendations introduced by the Illinois Department of Public Health and the Centers

for Disease Control and Prevention. A reservation form was created listing these guidelines. Those reserving park pavilions are required to sign and date the form acknowledging guidelines.

As of June 25, 2020, Supervisor Schulte reported all employees and guests entering the Town Hall are having their temperature taken. Anyone with a temperature above the CDC-recognized level will be sent home. He noted so far no one had a temperature above the CDC-recognized level. He also reported Township employees signed a COVID-19 certification packet confirming they had not traveled or had COVID-19 symptoms prior to July 1, 2020, which is the effective date of the certification.

Supervisor Schulte reported Garrett Valley, the scout who completed the kiosk and marker project for the trails at the park, recently achieved the rank of Eagle Scout. The Township is getting a plaque to place on site in acknowledgement of Mr. Valley's hard work.

A letter was sent the week of July 20, 2020 to past Touch-A-Truck supporters and businesses announcing the fall event had been cancelled due to the pandemic. Supervisor Schulte also noted a formal press release will be sent out soon notifying the community of the decision.

Additionally, Supervisor Schulte reported due to the pandemic, Edwardsville Township's Lunch and Learn programming has been suspended until further notice.

Supervisor Schulte reported the Supervisor's office staff started issuing Farmers' Market vouchers to seniors in Edwardsville Township and across Madison County. The annual summer program is available through the Illinois Department of Public Health and provides incomequalifying seniors with \$25 in vouchers to purchase fresh fruits and vegetables at area markets.

The Edwardsville Township Supervisor's staff will begin assisting clients with Illinois Home Energy Assistance Program applications August 3, 2020 for the 2020-2021 program year. Supervisor Schulte reported the Township has seen a greater need for this service since the start of the pandemic. Governor Pritzker allocated an additional \$250 million for IHEAP funding to assist the state's residents.

HIGHWAY COMMISSIONER'S COMMENTS: Highway Commissioner Picarella reported Herr Plumbing was awarded the bid for the Old Alton Road project. The project involves additional work outside the original scope of the project necessitating a change order.

Highway Commissioner Picarella reported the road crew has been cleaning up trees and other damage from recent storms. He noted the bucket truck has been useful in the completion of this work.

Highway Commissioner Picarella also reported crews have finished handicapped pads in the park and painted clear coat on restroom floors.

Additionally, Highway Commissioner Picarella noted his team is continuing to comply with COVID-19 safety procedures, including frequent hand washing and social distancing.
