#### **Edwardsville Township Meeting Minutes**

#### Wednesday, August 26, 2020

#### Draft September 23, 2020

The meeting of the Edwardsville Township Board was called to order by Supervisor Fred Schulte at 7:01 P. M. at the Glen Carbon Village Hall, 151 N. Main St., Glen Carbon, Illinois. Present were Supervisor Schulte, Trustee Kathie Duame, and Clerk David Schwind. Trustees Matt Chapman, Kevin Hall, Charles "Skip" Schmidt, and Highway Commissioner Danny Picarella were connected remotely. Township Assessor Judy Klopmeier was absent.

Trustee Hall led the Pledge of Allegiance.

PRESENTATION: None

PUBLIC HEARING: None

PUBLIC COMMENT: None

CONSENT AGENDA: Motion to approve the Consent Agenda, including the minutes for the July 22, 2020 meeting; the authorization of expenditures from July 11, 2020 – August 14, 2020, and the revised list of bills made by Trustee Duame, seconded by Trustee Schmidt. Motion Passed. Voting "Yes"—Trustees Chapman, Hall, Schmidt, Duame, and Supervisor Schulte.

CORRESPONDENCE: The Madison County Circuit Clerk Fine's Report for July 2020 was distributed. There were no fines collected for Edwardsville Township.

Notice was distributed to the board of a Madison County Zoning Board of Appeals Public Hearing held Tuesday, August 25, 2020. There were no Edwardsville Township properties reviewed during the hearing.

SUPERVISOR'S COMMENTS: Supervisor Schulte reported Edwardsville Township employees are conducting COVID-19 self-screenings upon arriving to work each morning. A list of COVID-19 symptoms is posted next to an employee sign-in sheet. Employees review the symptoms list prior to signing the self-screening sheet. Employees have been informed if they

are exhibiting any COVID-19 symptoms, they should immediately report that information to their supervisor. Supervisor Schulte noted the Township is working with Township Attorney Tonya Genovese to assure that cases are handled appropriately.

A new full-time park maintenance worker has been hired to work at Edwardsville Township Community Park. Supervisor Schulte reported Jered Busch joined the staff August 17, 2020 from the Village of Livingston. Mr. Busch has several years of experience.

The Edwardsville High School Interact Club donated a bench made of recycled plastic to the Park the week of August 24, 2020. Supervisor Schulte noted the bench was delivered and placed near Mabel's Playground near the Park's front entrance. There is a plaque on the bench acknowledging the donation. Students through the EHS Interact Club volunteer each year at the Township's annual Touch-A-Truck event. While the Township is unable to host Touch-A-Truck this year due to the pandemic, it was honored to work with the club for the delivery and dedication of the bench.

Supervisor Schulte stated on August 3, 2020, Edwardsville Township began helping clients with IHEAP applications for the 2020-2021 program year. So far, the office has processed more than 120 applications. Supervisor Schulte reported last month there was an increase in people with additional needs due to the pandemic. He stated the Township has been referring people to various community resources and assisting clients mostly by phone. He reported most individuals drop off paperwork in the office, and therefore, are in the facility less than 15 minutes at a time. Appointments are conducted via phone, which serves as an added layer of protection for Township employees and the public during the pandemic.

Supervisor Schulte noted the Township soon will submit reimbursement information for the Trees Forever Grant it was awarded in April. The three trees purchased through Market Basket were covered under the grant and have been planted at the Park. Supervisor Schulte noted the Township is grateful for the grant opportunity made available through Trees Forever. He added the interns were instrumental in us pulling together the necessary information and submitting the application.

It was reported by Supervisor Schulte that the Township was not awarded one of Illinois' Fast-Track grants for its building renovation and expansion project. He added the Township has not yet received word concerning the other two state grant applications filed with the Illinois Department of Commerce and Economic Opportunity. The Township should receive word on the status of the remaining two grant applications sometime in October.

Supervisor Schulte reported Community Outreach Coordinator Christine Doty and Administrator Beth Behrhorst took part in a General Assistance Training webinar today and received certification for it. The General Assistance allotment will need to increase from \$304 to \$321 to comply with state levels starting October 1, 2020. Supervisor Schulte noted the board had been advised of the need for the increased award amount last fall and that information was considered during the preparation of the current fiscal year budget. He further advised the board that the

Township Officials of Illinois have notified townships across the state that moving forward, there will be a 3-percent increase each fall to the allotment amount available for eligible constituents.

Supervisor Schulte also reported the quarterly investment report to the board.

HIGHWAY COMMISSIONER'S COMMENTS: Highway Commissioner Picarella informed the board that work along Old Alton Road is nearly complete. A guard rail is being installed and the road is expected to reopen Monday, September 15, 2020.

The Highway Commissioner reported Edwardsville Township Road and Bridge employees continue adhering to CDC guidelines recommending frequent hand washing and social distancing.

#### ORDINANCE NO. 2020-002

## AN ORDINANCE AMENDING ORDINANCE NO. 2019-005 SETTING PROVISION FOR COMPLIANCE WITH THE GENERAL ASSISTANCE HANDBOOK

WHEREAS, Section 306 ILCS 5/ Public Aid Code of the Illinois Compiled Statues mandates Edwardsville Township to administer General Assistance to residents of Edwardsville Township; and

WHEREAS, it is necessary for Edwardsville Township to establish practices and procedures ensuring its full compliance with the Code, so that the public policy stated therein can be carried out effectively and efficiently with respect to the records of the Township; and

WHEREAS, the Township Supervisors of Illinois have compiled the rules and regulations of General Assistance in the "General Assistance Handbook" to aid township governments with the administration of General Assistance;

WHEREAS, on October 1, 2018 the Illinois Department of Human Services adopted an increase in Flat Grant monthly payment level from \$304 to \$312 (Section 1.33 in the GA Manual); and

WHEREAS, at the November TOI Supervisors Division meeting, the recommendation was adopted increasing the maximum Flat Grant monthly payment level from \$304 to \$312; and

WHEREAS, Edwardsville Township received a letter from the Township Officials of Illinois Township Supervisors Division notifying the Township of this maximum Flat Grant monthly payment increase and plans to increase its allotment from the previous maximum allotment of \$304 to the maximum allowable allotment of \$312.

**NOW, THEREFORE, BE IT ORDAINED** by the Township Board of Edwardsville, Madison County, Illinois as follows:

**SECTION 1:** That the "General Assistance Handbook" is hereby adopted as the General Assistance rules and regulations of Edwardsville Township.

**SECTION 2**: That a current edition of the "General Assistance Handbook" will be utilized by General Assistance employees to ensure full compliance with the Public Aid Code.

**SECTION 3**: That the Asset Disregard will be defined as \$312.00.

**SECTION 4**: That the General Assistance payment level for an Adult Case will be defined as \$312.00.

**SECTION 5**: That the General Assistance payment level for a Family Case will be determined using section 9.09 of the "General Assistance Handbook".

**SECTION 6**: That this ordinance shall be in full force and effect amending Ordinance No. 2019-O05 after its adoption, as provided by law.
