Edwardsville Township Meeting Minutes

Wednesday, October 28, 2020

Approved November 18, 2020

The meeting of the Edwardsville Township Board was called to order by Supervisor Fred Schulte at 7:00 p.m. at the Glen Carbon Village Hall, 151 N. Main St., Glen Carbon, Illinois. Present were Supervisor Schulte, Trustees Chapman, Duame and Schmidt, Highway Commissioner Picarella and Clerk Schwind. Trustee Hall and Assessor Judy Klopmeier were connected remotely.

Trustee Chapman led the Pledge of Allegiance.

PRESENTATION: During a presentation to the Edwardsville Township board, Jamie Henderson, principal from Henderson Associates Architects of Edwardsville, presented four (4) options for the Township's proposed renovation and expansion. He advised the board of the differences among each of the plans.

PUBLIC HEARING: None

PUBLIC COMMENT: None

CONSENT AGENDA: Motion to approve the Consent Agenda, including the minutes for the September 23, 2020 meeting; the authorization of expenditures from September 12 – October 16, 2020, and the revised list of bills made by Trustee Schmidt, seconded by Trustee Chapman. Motion Passed. Voting "Yes"—Trustees Chapman, Hall, Schmidt, Duame and Supervisor Schulte.

CORRESPONDENCE: The Madison County Circuit Clerk Fine's Report for September 2020 was distributed. There were no fines collected for Edwardsville Township.

Notice was distributed to the board of a Madison County Zoning Board of Appeals Public Hearing held Tuesday, October 27, 2020. There were no Edwardsville Township properties reviewed during the hearing.

Included in the board packet were three thank you letters:

- Fred Albers of Glen Carbon for a condolence received from the Township for the passing of his son, John Albers;
- Joyce Dobrinich of Edwardsville for a condolence received from the Township for the passing of her sister, June Dobrinich;
- Washington University School of Medicine in St. Louis for a donation that was made by Township employees in memory of Jerry White of Edwardsville, the husband of Elaine White, an employee from the Assessor's office who retired over the summer.

COMMITTEE REPORTS: Minutes from Facility Planning Committee meetings held May 28, 2020 and October 20, 2020 were reviewed and approved. Chairman Chapman reiterated the points made by Mr. Henderson during his earlier presentation. Mr. Henderson presented four (4) options for the Township's renovation and expansion project. Chairman Chapman commented on the status of the two outstanding grants for which the Township applied: Notice on the Shovel Ready Grant should be known by mid-November and word on the Public Infrastructure Grant will not be available until after the first of the year.

ACTION ITEMS: Motion to Approve Option 3 for the Edwardsville Township Building Renovation and Expansion project, pending award of state grant funding was made by Trustee Chapman, seconded by Trustee Hall. Motion passed. Voting "Yes"—Trustees Chapman, Hall, Schmidt, Duame and Supervisor Schulte.

Motion to Pass Resolution No. 2020-R16 Setting Compensation of Township Officials for the Four-Year Term Beginning May 17, 2021 for elected officials and the Township Assessor, effective January 1, 2022-December 31, 2025, motion made by Trustee Chapman, seconded by Trustee Schmidt. Motion was amended set the Assessor's salary beginning January 1, 2022 at \$50,000 increasing the Assessor's salary by 2 percent each year thereafter for calendar years 2023, 2024 and 2025. Amended motion was made by Trustee Chapman, seconded by Trustee Duame. Motion Passed. Voting "Yes"—Trustees Chapman, Hall, Schmidt, Duame and Supervisor Schulte.

Motion to Pass Amended Resolution No. 2020-R16 Setting Compensation of Township Officials for the Four-Year Term Beginning May 17, 2021 to change Highway Commissioner's salary for 2021, 2022, 2023, 2024 to \$31,000, \$33,000, \$35,000 and \$37,000, respectively, made by Trustee Hall. No second. Motion failed due to lack of a second.

Motion to Pass Resolution No. 2020-R17 Authorizing a Contract for an Employee Insurance Package through United Health Care made by Trustee Chapman, seconded by Trustee Duame. Motion Passed. Voting "Yes"—Trustees Chapman, Hall, Schmidt, Duame and Supervisor Schulte.

Motion to Pass Resolution No. 2020-R18 Authorizing a Contract Renewal with SIUE (Town Intern) made by Trustee Duame, seconded by Trustee Schmidt. Motion Passed. Voting "Yes"—Trustees Chapman, Hall, Schmidt, Duame and Supervisor Schulte.

Motion to Pass Resolution No. 2020-R19 Authorizing a Contract Renewal with SIUE (Park Intern) made by Trustee Chapman, seconded by Trustee Hall. Motion Passed. Voting "Yes"—Trustees Chapman, Hall, Schmidt, Duame and Supervisor Schulte.

SUPERVISOR'S COMMENTS: Supervisor Schulte reported the Township still is waiting for word from DCEO regarding whether it will be awarded a Shovel Ready Grant. News should be available soon. He noted if the Township is not awarded a Shovel Ready Grant, DCEO should have news available about the Public Infrastructure Grant awards after the first of the year.

Supervisor Schulte reminded the board that nominating packets for the April 6, 2021 consolidated election cycle currently are available for pick up at the Edwardsville Township Hall.

Mandatory state Sexual Harassment Prevention Training must be completed by December 31, 2020. Supervisor Schulte reported to the board that Administrator Behrhorst emailed elected officials and employees the PowerPoint presentation that must be completed by the deadline in order for the Township to be in compliance with the state mandate. He encouraged elected officials to complete the training and provide the administrator with signed certificates of completion as soon as possible. He noted elected officials can call the administrator if they need assistance completing the training or have questions.

The Supervisor's staff has been busy fielding calls and assisting Edwardsville Township residents in many ways throughout the pandemic. Supervisor Schulte noted several hundred calls have come into the office since March 1, 2020. He added he is proud of the help provided by Community Outreach Coordinator Christine Doty in assisting clients with energy assistance applications on behalf of the county, the state's Benefit Access program, unemployment and SNAP benefit filing, Senior Health Insurance Program counseling, assistance to area transients and homeless people, and myriad other services. He said he is impressed by the team approach taken by Ms. Doty and the entire office staff, including the administrator and the Township's two SIUE MPA interns.

Supervisor Schulte reported Illinois' Senior Farmer's Market program ended a month early this year due to a lower than normal number of participants statewide. The low number of participants was attributed to the pandemic. Edwardsville Township issued 46 voucher packets between July and September, compared with 145 voucher packets between July and October, 2019.

HIGHWAY COMMISSIONER'S COMMENTS: Highway Commissioner Picarella reported Edwardsville Township Road and Bridge plans to enter an agreement with TWM Consulting Engineering Services for a reconstruction project on Frisbee Lane. He noted the project will begin in 2020 with Road and Bridge obtaining easements and moving utilities for reconstruction in 2021. He added the project is expected to go out for bid in 2021.

TOWNSHIP ASSESSOR COMMENTS: Assessor Klopmeier thanked the board for taking the time to speak with her earlier in the afternoon concerning the assessor's salary for 2022-2025, established during the meeting with the passing of Resolution No. 2020-R16.
