

RESOLUTION NO. 2021-R06

**AUTHORIZING PURCHASE COOPERATIVE AGREEMENT THROUGH THE
REGION VIII EDUCATION SERVICE CENTER (TIPS)**

WHEREAS, the Board of Trustees of Edwardsville Township of Madison County, Illinois, pursuant to the authority granted by 5 ILL. Comp. Stat. 220/2 & 3, desires to enter a purchasing cooperative agreement offered by the Region VIII Education Service Center, and in the opinion that by participating in the described purchasing program offered by the Regional VIII Education Service Center, Pittsburg, Texas (TIPS); and

WHEREAS, the Texas Educational Code §8.002 permits Regional Education Service Centers, at the direction of the Commissioner of Education, to provide services to assist units of government to exercise any powers, privileges, or authority jointly with any other public agency of Illinois, or any other state, which as the same powers, privileges, or authority; and

WHEREAS, the Illinois Intergovernmental Cooperation Act grants authority for public agencies to exercise any powers, privileges, or authority jointly with any other public agency of Illinois, or any other state, which has the same powers, privileges, or authority 5 ILL Comp Stat. 220/2-(1); and

WHEREAS, the definition of “public agency” includes any political subdivision of any other state 5 ILL Comp Stat. 220/2-(1); and

WHEREAS, a Texas regional service center is a political subdivision of Texas, Tex. Educ. Code §8.001, et seq.

NOW, THEREFORE, BE IT RESOLVED by the Township Board of Edwardsville, Madison County, Illinois as follows:

SECTION 1: That the Board of Trustees of Edwardsville Township authorizes entering an Interlocal Agreement with Regional Education Service Centers, for a tennis court resurfacing project at Edwardsville Township Community Park, 6368 Center Grover Road, Edwardsville, Illinois; and


SECTION 2: That the Board of Trustees of Edwardsville Township hereby directs and designates the Chief Elected Official to act as the authorized representative in entering the aforementioned Interlocal Agreement; and

SECTION 3: That the Board of Trustees of Edwardsville Township certify that the foregoing is a true and correct original Resolution duly adopted by the Edwardsville Township board and is filed on record at the TIPS office.

Motion was made by Trustee Duame, seconded by Trustee Schmidt
that the Resolution be adopted and approved by 5 Ayes and 0 Nays.


