Thank you to all that helped at the Rotary Criterium this past weekend. We had great weather and distributed all but 1 toddler helmet.

We are still seeking additional vehicles, sponsors and food trucks for the Touch A Truck event held on September 30. Adam, Christine, and the interns have been working hard as always on this big day.

Warren Woolsey started his internship experience this last week. MPA students have continued to be in short supply, but we do have a potential second option we hope to bring on. Marc Hohlt who finished his internship this month, is going to stay on a couple days a week through September 30 to help with Touch A Truck, grants, and other projects.

We have distributed 77 Farmer's Market Coupons. We have 23 remaining and will need to return the unused coupons by September 4th.

The building has moved along with them finishing painting the exterior today and a lot of exterior work has been on the parking lot. Yesterday they discovered the ground was, as Jamie called it "pumping" soil. When you walked in certain spots it was almost like walking on a waterbed. So, they are going to remove 18-24 inches of unsuitable soil and replace it with compacted rock. I don't know what this will cost us yet. Positive is Jamie said they are thinking they'll be done by the end of the year.

HIGHWAY COMMISSIONER'S COMMENTS:

Our oil and chipping of roads went well. Carrie is preparing for the audit.

Last night a big oak tree fell on a road. We called out to a crew to clear the roadway. We have been careful with the crews and the heat. We do the work in the early morning, such things as hauling rock and slacking in the trucks.
