FOR EDWARDSVILLE TOWNSHIP, MADISON COUNTY, ILLINOIS
FOR THE TAX YEAR 2023, COLLECTABLE IN 2024**

BE IT ORDAINED by the Board of Trustees of Edwardsville Township, Madison County, Illinois .
as follows:

SECTION 1: That the sum of **nine hundred fifty-five thousand dollars and 00/100 dollars (\$955,000.00)** are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

General Town Fund
Illinois Municipal Retirement Fund
Social Security Fund
General Assistance Fund

for the year 2023.

SECTION 2: That the amount levied for each object and purpose shall be as follows:

A) GENERAL TOWN FUND **\$804,500**

Total Amount Levied for General Town Fund to include the following areas: Administration (Elected Officials' Salaries, Personnel), Contracted Services, Commodities, Capital Outlay, Township Park, Other Expenditures. Township Assessor.

REF: General Corporate Tax 60 ILCS 1/235-10

B) ILLINOIS MUNICIPAL RETIREMENT FUND **\$43,500**

Total Amount Levied for IMRF Fund (to include Personnel).

REF: IMRF Tax 40 ILCS 5/7-171

C) SOCIAL SECURITY FUND **\$25,000**

Total Amount Levied for Social Security Fund (to include Personnel).

REF: Social Security Tax 40 ILCS 5/21-110 & 110.1

D) GENERAL ASSISTANCE FUND **\$82,000**

Total Amount Levied for General Assistance Fund (to include Administration & Assistance).

REF: Public Assistance Tax 60 ILCS 1/235-20

TOTAL TAXES TO BE LEVIED **\$955,000**

SECTION 3: That the Town Clerk shall make and file with the County Clerk of said County of Madison, on or before the last Tuesday of December, a duly certified copy of this ordinance.

SECTION 4: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not affect the validity of the remaining portion of this ordinance.

SECTION 5: That this ordinance shall be in full force and effect after its adoption, as provided by law.

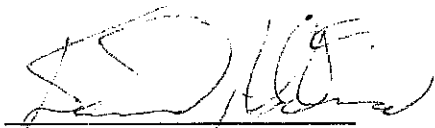

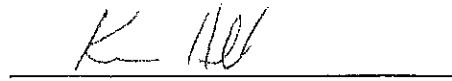

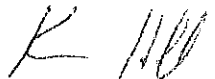
