AN ORDINANCE LEVYING TAXES FOR ROAD PURPOSES
FOR EDWARDSVILLE TOWNSHIP ROAD AND BRIDGE, MADISON COUNTY, ILLINOIS
FOR THE TAX YEAR 2022, COLLECTABLE IN 2023

BE IT ORDAINED by the Board of Trustees of Edwardsville Township, Madison County, Illinois as follows:

SECTION 1: That the Highway Commissioner of the Road District of Edwardsville Township does hereby determine and declare that the sum of **one-hundred eighty-nine-thousand four-hundred eighty nine dollars and eighty cents (\$189,489.80)** are hereby levied upon all property subject to taxation within the Township Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township Road and Bridge as required by statute or voted by the people in accordance with the law, for such purposes as:

General Road Fund
Illinois Municipal Retirement Fund
Social Security Fund

for the year 2022.

SECTION 2: That the amount levied for each object and purpose shall be as follows:

SECTION 3: That the Town Clerk shall make and file with the County Clerk of said County of Madison, on or before the last Tuesday of December, a duly certified copy of this ordinance.

SECTION 4: That the Board of Trustees does hereby certify that the amount levied herein is necessary to be raised by taxation for road purposes for Edwardsville Township Road and Bridge District.

SECTION 5: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not affect the validity of the remaining portion of this ordinance.

SECTION 6: That this ordinance shall be in full force and effect after its adoption, as provided by law.
