

**RESOLUTION NO. 2021-R10**

**A RESOLUTION AUTHORIZING A TRANSFER OF APPROPRIATIONS  
FOR THE GENERAL TOWN FUND**

**WHEREAS**, there was adopted on the 28<sup>th</sup> day of April, 2021, by the Board of Trustees of Edwardsville Township, Madison County, Illinois a Budget & Appropriation Ordinance for the fiscal year beginning April 1, 2020 and ending March 31, 2021; and

**WHEREAS**, it now appears that certain adjustments between appropriated line items in the General Town Fund in said ordinance are desirable and necessary; and

**WHEREAS**, Section 3 of the Illinois Municipal Budget Law (50 ILCS 330/3), as approved July 12, 1937, as amended, authorizes transfer between the various line items within any fund in such Appropriation Ordinance not exceeding 10% of the total amount appropriated in such fund by such ordinance.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Board of Edwardsville, Madison County, Illinois as follows:

**SECTION 1:** That there is hereby transferred from the unexpended balance of the line item **Provision for Contingencies – Assessor in the General Town Fund Two-Hundred forty-six Dollars and 34 Cents (\$246.32)** which transferred sum is hereby added to the line item **Equipment Purchase - Assessor Fund** in the same fund, making the adjusted appropriation for the **Equipment Purchase** line item **Four-Thousand Two-hundred Forty-Six Dollars and 34 cents** and the **Provision for Contingencies** line item **Three-Thousand Fifty-Three Dollars and 66 Cents (\$3,753.66)**.

**SECTION 2:** That there is hereby transferred from the unexpended balance of the line item **Provision for Contingencies – Assessor in the General Town Fund One-Hundred Thirty-Five and Zero Cents (\$135.00)** which transferred sum is hereby added to the line item **Drug Screening - Assesor** in the same fund, making the adjusted appropriation for the **Drug Screening** line item **Three-Hundred Thirty-Five Dollars and Zero Cents (\$335.00)**, and the **Provision for Contingencies** line item **Three-Thousand Six-Hundred Eighteen Dollars and Sixty-Six Cents (\$3,618.66)**.

**SECTION 3:** That there is hereby transferred from the unexpended balance of the line item **Provision for Contingencies - Assessor in the General Town Fund Fifty-One Dollars and Eleven Cents (\$51.11)** which transferred sum is hereby added to the line item **Dues & Subscriptions** in the same fund, making the adjusted appropriation for the **Provision for Contingency** line item **Three-Thousand Five-Hundred Sixty-Seven Dollars and Fifty-Five Cents (\$3,567.55)**, and the **Dues & Subscriptions** line item **One-Thousand Two-Hundred Fifty-One Dollars and Eleven Cents (\$1,251.11)**.

**SECTION 4:** That there is hereby transferred from the unexpended balance of the line item **Provision for Contingencies – Park in the General Town Fund Ten Dollars and Fifty Cents (\$10.50)** which transferred sum is hereby added to the line item **Fees & Services – Park** in the same fund, making the adjusted appropriation for the **Provision for Contingencies – Park** line item **Three-Thousand Nine-Hundred Eighty-Nine Dollars and Fifty Cents (\$3,989.50)**, and the **Fees & Services – Park** line item **Three-Hundred Ten Dollars and Fifty Cents (\$310.50)**.

Motion was made by Trustee Hall, seconded by Trustee Chapman  
that the Resolution be adopted and approved by Five (5) Ayes and Zero (0) Nays.
