

**RESOLUTION NO. 2025-R15**

**A RESOLUTION AUTHORISING A TRANSFER OF APPROPRIATIONS  
FOR THE GENERAL TOWN FUND**

**WHEREAS**, adopted on the 21<sup>st</sup> day of May, 2024, by the Board of Trustees of Edwardsville Township, Madison County, Illinois a Budget & Appropriation Ordinance for the fiscal year beginning April 1, 2024 and ending March 31, 2025; and

**WHEREAS**, it now appears that certain adjustments between appropriated line items in the General Town Fund in said ordinance are desirable and necessary; and

**WHEREAS**, Section 3 of the Illinois Municipal Budget Law (50 ILCS 330/3), as approved July 12, 1937, as amended, authorizes transfer between the various line items within any fund in such Appropriation Ordinance not exceeding 10% of the total amount appropriated in such fund by such ordinance.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Board of Edwardsville, Madison County, Illinois as follows:

**SECTION 1:** That there is hereby transferred from the unexpended balance of the line item **Provision for Contingencies** in the **General Town Fund Seven Thousand Six Hundred Forty Seven and Zero Cents (\$7,647.00)** which transferred sum is hereby added to the line item **Supervisor Office Employees** in the same fun, make the adjusted appropriation for the first line item aforesaid **Eighty Thousand One Hundred Forty Seven and Zero Cents (\$80,147.00)** and the second line item aforesaid **Seven Thousand Three Hundred Fifty Three and Zero Cents (\$7,353.00)**.

**SECTION 2:** That there is hereby transferred from the unexpended balance of the line item **Provision for Contingencies** in the **General Town Fund One Thousand Seven Hundred Forty Seven and Zero Cents (\$1,747.00)** which transferred sum is hereby added to the line item **General Insurance** in the same fun, make the adjusted appropriation for the first line item aforesaid **Eighteen Thousand Seven Hundred Forty Seven and Zero Cents (\$18,747.00)** and the second line item aforesaid **Five Thousand Six Hundred Six and Zero Cents (\$5,606.00)**.

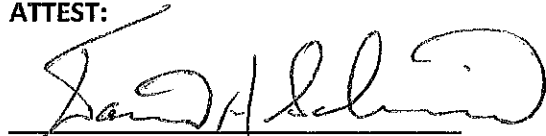
**SECTION 3:** That there is hereby transferred from the unexpended balance of the line item **Provision for Contingencies** in the **General Town Fund Four Hundred Three and Zero Cents (\$403.00)** which transferred sum is hereby added to the line item **Building Maintenance** in the same fun, make the adjusted appropriation for the first line item aforesaid **Six Thousand Four Hundred Three and Zero Cents (\$6,403.00)** and the second line item aforesaid **Five Thousand Two Hundred Three and Zero Cents (\$5,203.00)**.

**SECTION 4:** That there is hereby transferred from the unexpended balance of the line item **Provision for Contingencies** in the **General Town Fund Seven Thousand Five Hundred and Zero Cents (\$500.00)** which transferred sum is hereby added to the line item **Legal** in the same fun, make the adjusted appropriation for the first line item aforesaid **Six Thousand Five Hundred and Zero Cents (\$6,500.00)** and the second line item aforesaid **Four Thousand Seven Hundred Three and Zero Cents (\$4,703.00)**.

Motion was made by Trustee Chapman, seconded by Trustee Nutsukpu,  
that the Resolution be adopted and approved by Five (5) Ayes and Zero (0) Nays.
