**A RESOLUTION RELATING TO THE PARTICIPATION IN THE ILLINOIS
MUNICIPAL RETIREMENT FUND OF THE EDWARDSVILLE TOWNSHIP
HIGHWAY COMMISSIONER**

WHEREAS, on October 15, 2024, the Edwardsville Township Board passed an ordinance setting compensation for Township Officials for the four-year term beginning May 19, 2025; and

WHEREAS, the compensation ordinance passed on October 15, 2024, allowed the position of Edwardsville Township Highway Commissioner to participate in the Illinois Municipal Retirement Fund (IMRF); and

WHEREAS, Danny Picarella was elected as the Edwardsville Township Highway Commissioner for a four-year term at the April 1, 2025 election; and

WHEREAS, Danny Picarella, as the Edwardsville Township Highway Commissioner elected for a four-year term (Term) at the April 1, 2025 election, elects to individually opt-out of participation in IMRF.

NOW, THEREFORE, BE IT RESOLVED by the Township Board of Edwardsville Township, Madison County, Illinois as follows:

SECTION 1: Danny Picarella elects to opt-out of participation in IMRF while fulfilling his Term as Edwardsville Township Highway Commissioner.
