We have been working on the 2025/2026 budget.

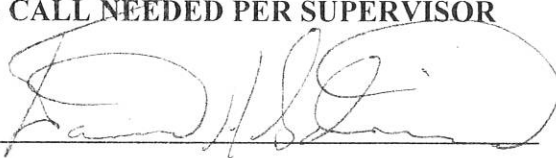
ASSESSOR'S COMMENTS: None
