SUPERVISOR'S COMMENTS:

- The month of November brought in 39 SHIP appointments and seventy-nine for LIHEAP. This kept Christine busy in General Assistance. She was also recognized in the Glen Carbon community magazine for her work on those programs for Glen Carbon residents at their Senior Center.
- LVG is still working on the solar panel rebates for the township. They classified the status as "in limbo." Hopefully, we will still see some funding come back.

- With the passage of the Levy this evening, we will start the budget planning process for the 2026-2027 fiscal year. There will be increases in the cost of health insurance and other benefits provided by the township to our personnel. The health insurance rate alone will see a 25.6% increase as of January 2026-the coverage runs on the calendar year. We will also have new staff signing up for coverage in January.
- The township administrative staff will be assessing other financial institutions for possible transfer of accounts after the fraud check experience with our current bank for our checking accounts. Some charge for the “positive pay” feature and others do not so we will be reviewing options heading into the new year.
- New financial assistant, Ted Tiernan, started earlier this month and is becoming familiar with our financial systems and accounts. He will be instrumental in the conversion to QuickBooks and attended TOI training last Friday with Administrator Ayers in Springfield.
- Wishing everyone a very Happy and Safe Holiday Season and Happy New Year too! To celebrate the holidays, I have Armenian Pakhlava pastry for a treat after tonight’s meeting. Thank you to ALL our Edwardsville Township elected officials, staff, and volunteer supporters for a great 2025. We could not accomplish all that we do without your dedication to the community. See you next year!!

HIGHWAY COMMISSIONER’S COMMENTS:

- We had two snowstorms so far in December. We had some minor breakdowns, but overall, everything went well.
- Old Alton/Edwardsville Rd. was resurfaced. It still needs to be striped and to have the guardrails replaced.
- Madison County will be having their household hazardous waste collections again this year. The dates will be January 10th and February 14th, 2026 in Wood River.

ASSESSORS’ COMMENTS:

- My Chief Deputy, Jessica, and I attended the annual Assessors meeting this morning, where several important updates were discussed. The PTAX 340 Low-Income Senior Citizen Assessment Freeze income threshold will increase to \$75,000 in 2026. Additionally, the budget for our current computer programs is expected to remain consistent with the 2024–2025 budget, with no significant changes anticipated.
- The Board of Review process is currently in progress, with hearings continuing through February. We have 168 appeals for our township.

- Jessica, Aaron, and I have registered for classes for the upcoming year to ensure we continue our professional education and training.
- My staff and I would like to extend our warm wishes to everyone for a wonderful holiday season. We look forward to working with you in the new year.
