SUPERVISOR'S COMMENTS:

The office is still filling the part-time finance position. The most recent candidate returned to her prior place of employment for full-time work. Considering this, we postponed the conversion to QuickBooks at this time. It is still my desire to move away from Sage and to QB's when staffing and time allows.

We are adding staff at the Township Park. Administrator Ayers has been covering tasks at the park in her capacity as Park Superintendent in addition to her duties in the office. A seasonal worker was added this past weekend, and a full-time staff member will be joining us on June 1st.

The annual building loan payment of \$182,450.65 was made last week and will show up on the May-June financial reports at our next meeting. The funds were transferred from Town to Capital Development by the budget, for payment to First Mid-Bank and Trust by May 15th.

The Edwardsville Rotary Club Criterium is coming up on August 15th, and we can always use assistance with the Township's bicycle safety service program at the event.

We are accepting donations, vendors, and vehicles for display at the upcoming Touch-A-Truck event on September 12th. Materials have been sent out to local businesses, and several have submitted donations in support of the annual event.

With each heavy rainfall, we have experienced some water infiltration in the basement. Photos have been taken and forwarded to the architect, building contractor and township attorney. We are still awaiting a resolution of the building drainage issues.

SECTION 2: That the Board of Trustees of Edwardsville Township will agree to pay a total of **\$7,000.00** due by August 1, 2026.

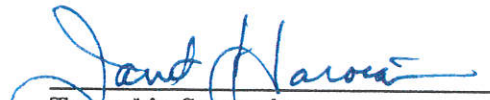
